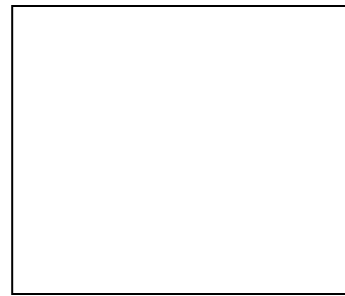

2. Two Passport Size Photographs (2 Passbilder).
3. For Business Visa, letter of invitation from firm in Pakista.
4. Letter of invitation to attend Seminar/Conference or any other event in Pakistan.
5. Letter of invitation to undertake Consultancy in Pakistan.
6. Visa fee may be deposited at any Branch of Post Bank in **A/c. No. 759641-468, PostBank  
BLZ No. 440 100 46 Dortmund**

Fee for German Passport:

- a. Tourist/family visa ( single entry)\*36
- b. One year multiple visa for ex-Pakistani nationals ) \*50
- c. Business visa \*80
- d. German Passport (German origin, double entry ) \*45
- e. German Passport (Afghan origin, double entry ) \*45

7. Pakistan origin German National desirous of obtaining one year multiple entry visa are required to provide proof of their Pakistan origin (copy of CNIC or Passport plus a copy of birth certificate of children)

8. Visa application by Post:

- ( i ) Visa form alongwith original stamped Bank receipt. (Überweisung)
- ( ii ) Self-addressed stamped envelope for return of documents.

9. Consular Working Hours.

Monday – Thursday : 0900- 1200 Hours.

Applicants are advised to apply for visa at least one week before their scheduled departure of Pakistan.
